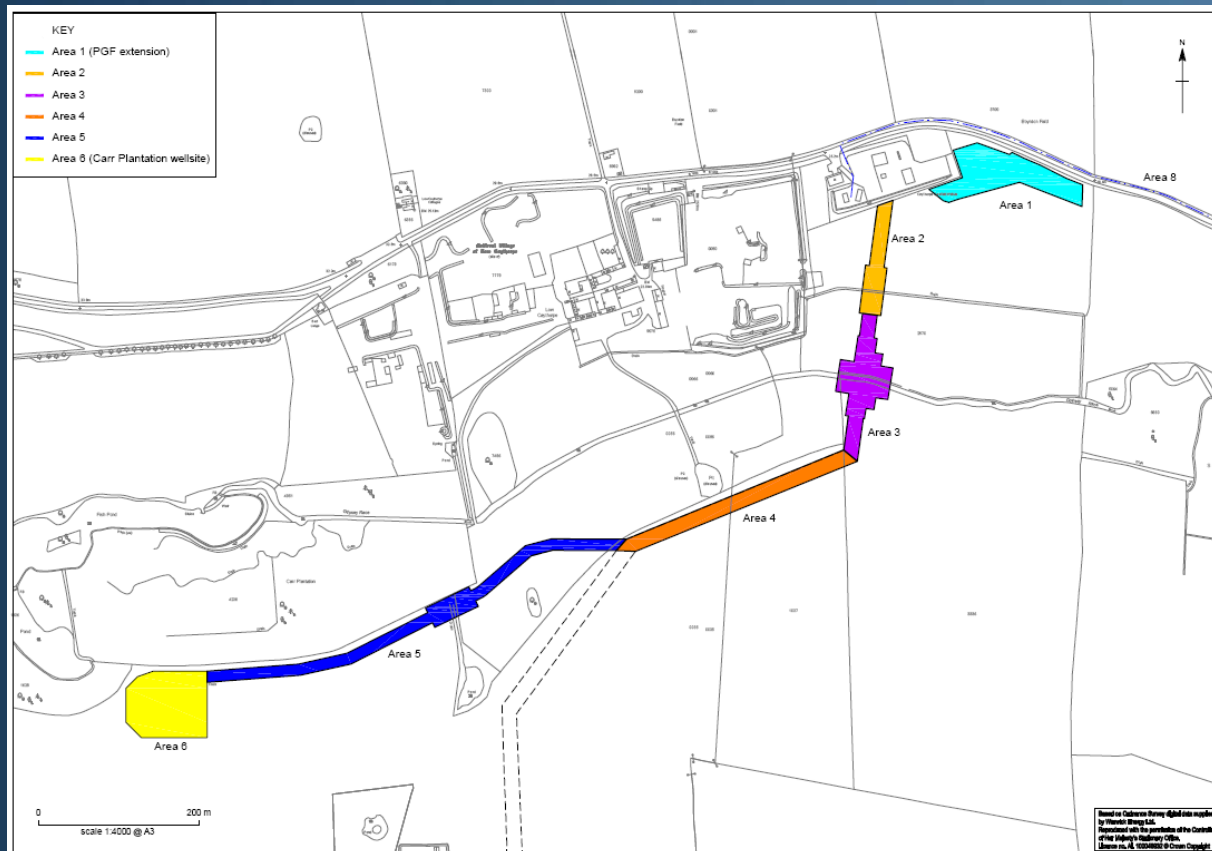

# Community Support Fund

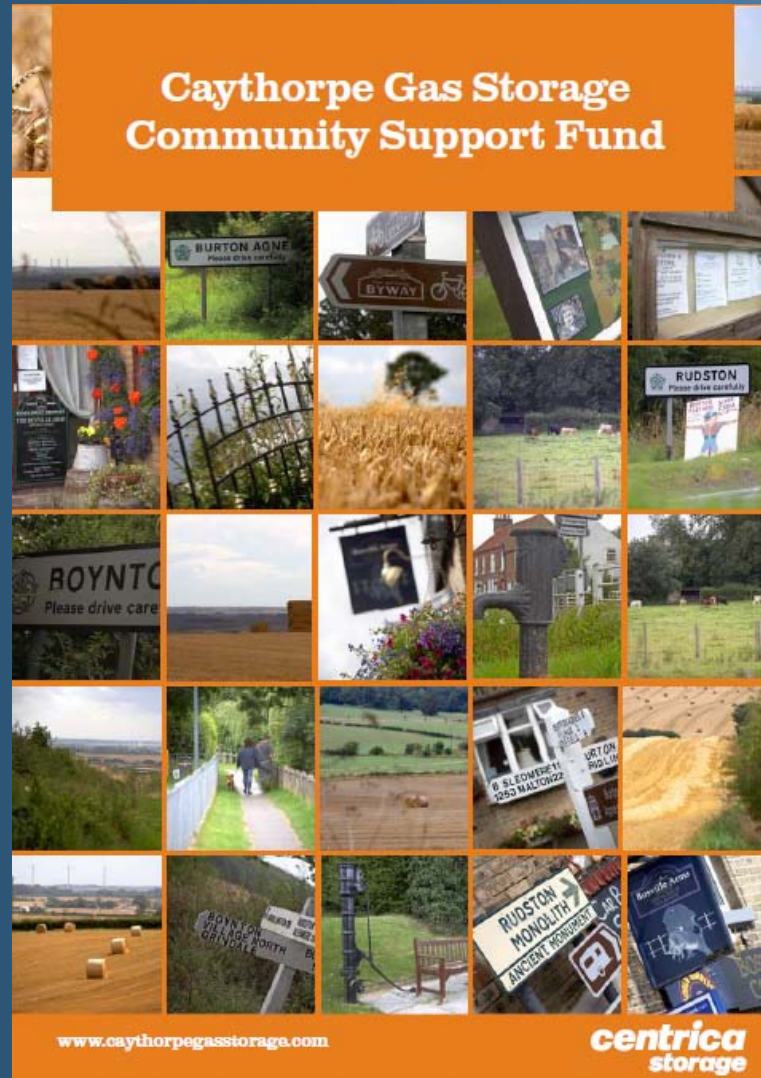
- The Caythorpe Community Fund has been established by Centrica Storage Limited as part of the company's giving back policy, for the communities of Rudston, Boynton and Burton Agnes.
- The fund, which is an initial one-off sum of £150,000, is available up until the completion of construction of the project.
- Decisions on the allocation of monies from the Community fund will be made by Centrica, although it is envisaged the liaison committee will have sight of the applications.

# Environmental Support Fund

- The Environmental Support Fund was established, in agreement with East Riding of Yorkshire Council, as a means of supporting improvements to the natural environment in the parishes of Boynton, Rudston and Burton Agnes.
- The fund has an ongoing annual budget of £5,000 over the 24 year lifespan of the Caythorpe Gas Storage Project planning permission.
- Details of the fund as per a previous agreement between Warwick Energy and East Riding of Yorkshire Council.
- Decisions as to the projects that receive monies from this fund will be made by the Caythorpe Gas Storage Liaison Committee.
